We had a lively and interactive discussion about important recent and upcoming issues in optometry. The COA leaders also shared a presentation on the benefits and resources available to COA/TCOS members. For those who have not yet had the opportunity to attend a COA House of Delegates, it was an excellent synopsis on the value of membership.

MINUTES FOR THE OCTOBER 19, 2013 GENERAL MEETING

President Weitkamp called the meeting to order at the Sycamore Hot Springs Resort in Avila Beach at 1:00pm. SECRETARY'S REPORT: (Mayhew) The minutes from the August 11, 2013 meeting at the Firestone Brewery were approved by the membership (Chowins/Lowry).

TREASURER'S REPORT: (Alford) The Union Bank checking account balance is \$38,750 and \$8734 in the vision One Credit Union Savings Account. Our 2013 income to date is \$21,153 where \$15,250 of that amount was from Sponsorship checks. Our expenses year to date are \$13, 494. The treasurer's report was approved by the membership (Hider/Chowins).

MEMEBERSHIP REPORT: (Lowry) Membership is stable for the TCOS. There are two new graduates in the area and we will invite them to join.

GOVERNMENTAL AFFAIRS: (Weitkamp for Gronquist) The COA met with OMD's to form a committee to monitor the subject of Optometrists giving vaccinations.

-SB 305 allows our previous bill not to sunset

-SB 430 would require children to get their eyes examined before they enter school and every three years until the eighth grade. This was held in the Assembly as due to opposition from pediatricians.

-SB 491 the measure would have allowed nurse practitioners to practice without direct physician supervision. This bill was held in Assembly Appropriations Committee.

-SB 492 redefines the practice of Optometry. The COA will be working with the legislature to come up with a certification process to perform advanced procedures.

-SB 493 expands the scope of practice of pharmacists. It allows them to give vaccinations and fill some prescriptions without doctor supervision. This bill was signed into law.

-SB 724 provides limited immunity from liability to non-profit organizations and volunteers that provide vision screenings. This bill was signed into law.

-SB 809 would have raised fees on health care providers to pay for a database that monitors scheduled drug prescriptions. There was a request to amend the bill to more fairly distribute the costs of the database. The bill was signed into law.

PRESIDENT'S REPORT: (Weitkamp) The Christmas party will be at the Biltmore in Montecito on December 7, 2013. More information will follow.

-The next meeting will be on January 26th 2014 at the Tower Club in Oxnard.

-The NOOR free clinic in San Luis Obispo has received a visual field machine and an HRT but is in need of a pachymeter.

The meeting was adjourned by President Weitkamp at 1:10pm.

Lois Capps' District Representative Betsy Umhofer read a statement from the Legislator and this is a summary from that statement:

Ms. Capps feels that she has a valued relationship with Optometry. More people are looking at healthcare in a holistic way and Optometry being a primary care profession is a first line of eye care in most patients' lives. More people will be able to get to obtain eye exams through the Affordable Health Care Act. Lois Capps is proud to be one of 80 bi-partisan co-sponsors of HR-855 which is attempting to get parity in Medicaid with physician payments. We have been recognized by Medicare for 25 years as equal care providers and it is time Medicaid did the same.

Bill Howe, executive director for the COA also spoke to us:

-The House of Delegates will on April $4 - 5^{\text{th}}$ in Indian Wells. Legislative Day will be on May 13, 2014 in Sacramento. This is a great opportunity for all Optometrists to meet with their legislators and help them to understand what Optometrists are trained to do.

-SB-492 Protects what we are already doing

1) It will eliminate the medication list

2) It expands primary care role (Vaccinations, Diagnosis of diabetes, hypertension, and hyper cholesterol) 3) Advanced procedures:

New certification will be a 22
