

#### MINUTES FROM THE OCTOBER 15, 2011 GENERAL MEETING

President Ruth Marquez called the meeting to order at the Ventana Grill in Pismo at 1:27pm

SECRETARY: (Mayhew) The minutes taken by Lauren Tobin for the July 23, 2011 meeting at the firestone Brewery in Buellton were approved as written (Langsford/Tobin)

TREASURER: (Alford) We currently have \$23,638.04 in the checking account and \$8672.67 in the Vision One account. Vistakon, Transisions, NVision, Ista, PEN, Allergan, Essilor and Ophthonix have all helped sponsor our meetings this year.

- -Due to the fact that we receive sponsorship monies at all times during the year, the expense reports for each meeting are probably inaccurate. It was suggested that we consider quarterly expense reports versus meeting profit and loss reports.
- -The Buellton summer meeting had about \$1077.08 in expenses and \$3710 in revenue. Operating expenses are abo \$20,000 per year with the CE taking up the largest expense. The House of Delegates in the second largest expense with about \$200 to \$400 going out per delegate. Other expenses include the Christmas party, Legislative day, Presidents Council, the Visionary and the Web site.

PRESIDENT ELECT: (Chowins) Jason Lam has stepped down from the position of president elect and Dr. Chowi has taken over his position. Our guest in attendance was Laurel Hammang.

#### GOVERNMENTAL AFFAIRS STATE: (Langsford)

The Christmas party will be December 3<sup>rd</sup> at the Tower Club in Oxnard. It is free to members and a guest. The happy hour will start at 5:00 with dinner at 6:00. There will be an elephant gift exchange so find that thigh buster.

- Joanne Gronquist will be taking on the office of State Governmental Affairs in January. Dr. Langsford is running for a position on the COA Board of Trustees- Vote for him in February as a delegate at COA's House of Delegates. The deadline to sign up as a delegate is November 11, 2011. We will have 8 delegates and as many alternates that would like to attend.
- -Assembly Bill 778 is an attempt to change the current law, which prohibits the employment of Optometrists by Opticians, and prohibits interference in clinical decision making by Opticians and optical companies. The COA is not trying to put Lenscrafters/EyeExam out of business, only
- trying to protect Optometrists' rights.
- -CCR 1513 (California Code of Requirements)- the State Board of Optometry is considering a requirement to make Optometrists use their full name (no shortened, alternate, or nick-names) in any sort of advertisement, listing, etc.
- -CCR 1536 The State Board of Optometry is considering an increase in the allowable number of CE credits that may be obtained via correspondence from 20 to 25 per two-year licensure period.
- -The COA Legislative Day will be March 20, 2012. We are looking for volunteers to go to Sacramento and speak with Legislators and their staffers about issues affecting our profession.
- -Donate now to the AOA PAC. This can be done monthly or all at once. Our dues only pay for the staff members but PAC money goes to help sponsor legislators who are helpful to Optometry.

#### MEMBERSHIP: (Marquez for Lowry)

- -Three TCOS members were reinstated and there were three new pending members: Carter Andersen of Santa Barbara, Nicole Le of Moorpark, and Nicolas Rodriguez of Santa Paula.
- -Eyehelp.org is a COA public service that offers awareness for annual eye exams to the public and has the "Find a Doctor" tool. Our members can go to the website and make sure their information is there and up to date.
- -We would like to let non-COA doctors come to a meeting free in their area to try to get them to join the COA. Perhaps we could try to contact these non members in the area where the COA is to take place and personally invite them.
